Eligibility	Who is eligible to use Tuition Assistance?	<ul> <li>Full-time active UAW represented hourly employees who have acquired 90 days of employment</li> <li>Temporary UAW hourly employees who have acquired 90 days of employment or more, may utilize Personal Development Assistance (PDA) for Industrial Readiness Certificate Program (IRCP) courses only. PDA IRCP funding for Temporary employees become effective 90 days following the effective date of the 2019 CBA, or February 17, 2020</li> </ul>
Schools/Courses	Are all schools/courses approved?	Not all school/courses/fees are covered by tuition assistance. It is strongly recommended to submit an application in advance to make sure selected school and course(s) are approved
Deadlines	What are the deadlines for using Tuition Assistance?	<ul> <li>ETAP applications must be submitted no later than 45 days after term start date.</li> <li>PDA classes must be approved prior to class start date.</li> <li>Book reimbursement must be submitted no later than 90 days after term start date</li> <li>Invoices requesting payment must be received by the NPC from the school no later than 9 months from term start date</li> </ul>
Reimbursements	Are reimbursements available?	No – With the exception of textbooks, Tuition Assistance is a prepayment program. UAW-Ford pays the school directly
ЕТАР	What is the Education Tuition Assistance Plan (ETAP)?	Up to \$6,000/yr for tuition/fees for approved courses leading to a certificate/diploma, or degree (Associate, Bachelor, Master, or PhD) from a regionally accredited school
PDA	What is Professional Development Assistance (PDA)?	Up to \$3,000/yr for job related courses including:  Industrial Readiness Certificate Program (IRCP)  Labor Studies courses & conferences  Dale Carnegie, including online courses  LJPR Financial Education Programs
PDA EEC	What is a PDA Educational Enrichment Course?	Up to \$1,500/yr for Continuing Education, Lifelong Learning, or Personal Development Courses (including online) at regionally accredited schools or other educational institutions approved by the NPC
Textbooks	Are textbooks covered?	Yes - <b>\$600/yr</b> may be used for textbooks Includes E-Books, book rental, and books purchased through on-line retailers and applicable shipping costs
Vouchers	What is the Official Tuition Voucher?	Once classes are approved, an Official Tuition Voucher will be issued to the employee. The employee submits this to the school for payment
